Please read the following notes before signing the form.

- Before being allowed access to the Bodyworks equipment, **the teen applicant together with their nominated adult(s), MUST receive a Gym Induction.** This course gives advice on the safe and sensible manner in which to use the equipment.
- During public sessions, **a teen 12-15 years must be accompanied** by an adult (over 16 years) in the Bodyworks Gym.
- **The accompanying adult must take responsibility for the teen while in the gym and ensure their safe and proper use of the equipment, as outlined in the gym induction.**
- Your attention is drawn to the fact that individuals can put themselves at risk if the proper guidelines are not followed. In particular, young people, whose bodies are still developing, must be fully aware of the possible damage that can occur through misuse of gym equipment.
- If the accompanying adult wishes to participate in a gym session at the same time as the teen, this is permitted providing:
 - I. They uphold their responsibilities as the accompanying adult and their activity does not put the teen at risk.
 - II. The adult's gym session is paid for either via a membership or pay as you go admission rate.
- If the accompanying adult intends to only supervise the teen, and not participate in any activities themselves, admission is free of charge.

Centre Management reserve the right to withdraw permission to use gym equipment if it is not being used in a safe and responsible manner.
